- (a) to the extent that we are required to do so by law;

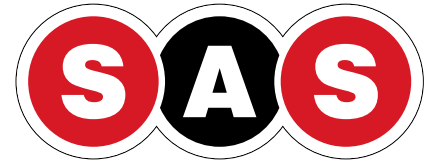
